✓ **Responsibility for Pet Behavior.** I agree to pick up after pets inside the room and in all public areas and use the designated relief areas. Pets are not allowed in any private space, public space, or reception area. Pets and owners are not allowed to loiter at any entrance to the building, except for entering and exiting. **Initials** \_\_\_\_\_

✓ **Damage and Soiling.** I agree to accept full responsibility for any and all damages and/or soiling caused by my pet during my stay. I understand that the costs of repair, replacement or additional cleaning requirements beyond the normal deep cleaning (including labor) will be charged accordingly. Owners may not use hotel towels or linens to bathe pets. **All pets must be housebroken.** **Initials** \_\_\_\_\_

✓ **Unattended Pets.** I understand that my pet, when left unattended in my hotel room, must be in an owner-provided kennel. A Pet-in-Room sign must be placed on the exterior guest room door at all times when the pet is in the room. My pet must be kept on a leash at all times in the interior and exterior public spaces of the hotel. Pets not on a leash or under positive control may be removed from the property without liability on the part of NGIS. I will assume any costs for such removal. **Initials** \_\_\_\_\_

✓ **Pet Amenities.** I will be responsible for all amenities, i.e. kennel, mats, leashes, food/water dish, litter box and relief bags. **Initials** \_\_\_\_\_
